When you call the U.S. Copyright Office on its toll-free line, you will be given three choices. To request publications or get recorded information about copyright, *press 1*. To obtain technical support for online registration, *press 2*. To speak to an information specialist about copyright or registration requirements, *press 0*.

1 Recorded Information about Copyright

Press 1 to obtain information about filing fees, registration options, location and hours of the Copyright Office, procedures to obtain or search copyright records, and other details. You can also choose to leave a voice mail message requesting paper application forms or circulars. Recorded information is available 24 hours a day.
